STATUS THE FOUNDATION FOR THE DEVELOPMENT OF EDUCATION AND CULTURE ALBIZ Saraj Skopje

I. GENERAL PROVISIONS

Definition of the organization

Article 1

Foundation for Development of Education and Culture ALBIZ Saraj Skopje (hereinafter: Foundation Albiz) is a civil society organization registered under the Law on Associations and Foundations of RM

Name of the organization

Article 2

Name - the name of the foundation is: Foundation for Development of Education and Culture ALBIZ Saraj Skopje

The abbreviated company name reads ALBIZ Saraj Skopje.

The name of the foundation of the English language will read: Foundation for development of education and culture ALBIZ Saraj Skopje.

The title of the Albanian language and Latin script: Fondacioni për zhvillimin e arsimit dhe kulturës ALBIZ, fsh. Saraj Shkup

Article 3

The founders by members of the Council of donors have specific rights under this Statute in deciding the adoption, amendment of the statute, the general policy and strategy, as well as status changes and termination of the Foundation Albiz.

II. STATUS OF FOUNDATION ALBIZ

Status of legal entity

Article 4

Albiz Foundation has legal personality or a foundation, rights, obligations and responsibilities defined by law and this Statute.

Seat

Article 5

The headquarters of the Foundation Albiz are in Skopje.

Str.20 No.97 Saraj Skopje

Decision to change the seat of Foundation Albiz need to be adopted by the Council of donors.

Emblem

Article 6

Foundation Albiz has an emblem. The appearance, shape and size of the sign is determined by the Council of donors, upon proposal of the CEO.

Stamp

Article 7

Foundation Albiz have a stamp, which has a circular shape and it is inscribed text in Macedonian language in Cyrillic script: Фондација за развој на образование и култура АЛБИЗ, с.Сарај Скопје and the Albanian language and Latin script: Fondacioni për zhvillimin e arsimit dhe kulturës ALBIZ, s. Saraj Shkup.

The shape and use of the seal and stamps determines the CEO in accordance with the law.

III. OBJECTIVES

Vision, mission and main goals

Vision

Article 8

The vision of the Foundation Albiz is to be a leader in promoting corporate social responsibility and philanthropy by organizing and promoting programs of educational, cultural, economic and socoi-humanitarian character in the society.

Mission

Article 9

The mission of the Foundation Albiz is to strengthen and enhance society by creating opportunities, providing educational, economic, social platforms and programs.

Main goals

The main goal of the Albiz Foundation is contributing to perform the required activity and research in order to develop scientific, educational, cultural and socio-humanitarian activities:

- Awarding grants to support successful students;
- Development of non-formal education through training courses and seminars;
- Support of culture through cultural events and works, maintenance of cultural associations and established additional cultural activities, festivals and other celebrations;
- Support of sports clubs and sports associations, set additional sporting activities, projects and events;
- Support projects and activities reffering to social activities and the development of economic activities;
- socio-humanitarian activities related to providing assistance to social cases, health and educational institutions and organizations, providing humanitarian aid (food, clothes, shoes, toiletries, bedding) to assist the most vulnerable people, providing funds and food to help people who are in a difficult financial situation;
- Assistance in solving infrastructure problems of a particular group of people;
- Ensuring cooperation between related institutions in the country and abroad;

Values

Article 10

Foundation Albiz is based on the following values: honesty, professionalism, accountability and transparency.

Target territory

Article 11

Foundation Albiz acts on the territory of the Republic of Macedonia.

Foundation Albiz can be organized on the territorial principle, by establishing organizational units (branches, offices, subsidiaries, etc.) that do not have legal status.

IV. MANAGEMENT (BOARD), MANAGEMENT AND ORGANIZATIONAL STRUCTURE

1. BODIES AND GENERAL MANAGEMENT (BOARD) AND SUPERVISION (COUNCIL OF DONORS)

Bodies of the general management and supervision

Article 12

Bodies of the general management and supervision of the Foundation Albiz are: Council of donors and the Board.

2. Common Provisions

Principle of non enforceability of the bodies of the Foundation Albiz

Article 13

Council of donors and the Board are composed exclusively of non-executive members, or members who are not involved in the daily management (Board of Directors) and is not employed by the Foundation Albiz.

Election of members

Article 14

Members of the Council of donors are the founders of Foundation Albiz. Board members are elected by the Council of donors.

Multiple stakeholder approach

Article 15

In Albiz Foundation it reflects the spirit of partnership between the founders. Management Board reflects the different social interests and stakeholders in the areas of activity of the Foundation Albiz, from the founders, people with integrity and competence

Personal capacity performances

Article 16

Members of the general management (Board of Directors) and surveillance (Council of donors) act in a personal capacity and decide according to personal convictions.

Way of work

Article 17

The bodies of general management (Board of Directors) and surveillance (Council of donors) work on sessions.

Quoruom of work and decisions

Article 18

The bodies of general management (Management Board) can work and make decisions if the session is attended by the majority of members.

The bodies of general management (Board of Directors) and surveillance (Council of donors) decide by a majority vote of the members present, unless the law or this Statute otherwise specified majority or other conditions are prescribed in respect of the majority for passing decisions on certain specific issues.

The voice of the chairman of the authority of general management (Board of Directors) and surveillance (Council of donors) is decisive in case of equal votes (equal number of votes).

Voting

Article 19

The bodies of general management (Board of Directors) and surveillance (Council of donors) decisions are made by public voting, unless by law and this Statute stipulates otherwise. Election and dismissal of the member of the general management (Board of Directors) and surveillance (Council of donors), the way of voting is determined by council in a separate decision.

Meetings with conference bond

Article 20

Members of the general management (Board of Directors) and surveillance (Council of donors) can participate and decide on the meeting organized by conference bond.

Decision without holding meetings or absence

Article 21

Members of the general management (Board of Directors) and surveillance (Council of donors) may decide without holding a meeting or without presence if members give their consent for the decision to be adopted, by a signature or a signature sent by fax, email or sms.

Cup of interests

Article 22

Members of the general management (Board of Directors) and surveillance (Council of donors) at any time should take into account primarily the goals and interests of the Foundation Albiz over individual or objectives of any other party.

Rights and duties

Article 23

Members of the general management (Board of Directors) and surveillance (Council of donors) have the right and duty to participate in the work of bodies that have been selected to provide ideas and initiatives for general acts and to participate in the exercise of other powers of bodies which are selected in accordance with the rules and the Council conclusions of donors and the Board.

Prohibition on participation in the executive and political parties

Article 24

Members of the general management (Board of Directors) and surveillance (Council of donors) can not be members of the government, and president and vice-presidents, ministers and deputy ministers. Members of the general management (Board of Directors) and surveillance (Council of donors) can not be presidents of political parties.

In the event of choice for carrying out functions referred to in paragraphs 1 and 2 of this article, membership in the bodies' stops, which is concluded by the Council of donors of the Foundation Albiz.

Responsibility

Article 25

The bodies of general management (Board of Directors) and surveillance (Council of donors) collectively and each of its members individually responsible for their work to the body that has elected them.

Dismissal and resignation of board member

Article 25

Council donor may vote distrust of the Board as a whole or its individual members. Distrust can be voted in case of default rights and obligations under the Statute and general acts, especially but not switch off for: breach of the provisions of the Statute, deviation from utverdenata long-term policy and

strategy of the Foundation Albiz and inability to maintain session Board of Directors for a period of six calendar months due to lack of quorum.

Chairman of the Board may propose the dismissal of a board member. Dismissal of a member of the Board may be proposed because of the absence of unjustified reasons at least three consecutive meetings of the Board or due representation of the Foundation which is not in accordance with the role, mission and identity of the Foundation or due to treatment contrary to the provisions of the status.

Board member may be resign

The choice of vacancies is done in the original mandate.

Permanent and temporary bodies

Article 26

For debating the issues within its competence, the Council of donors and the Board establish committees and other working bodies that are established as permanent or only temporary.

Remuneration of the members

Article 27

Members of the general management (Board of Directors) or the Board may receive reimbursement for costs and lost income incurred due to participation in the work of the general management (Management Board) by the Foundation Albiz

Remuneration is regulated by the Council of donors.

3. COUNCIL OF THE FOUNDATION DONORS ALBIZ

Definition of the Council of donors

Article 28

Council of donors of the Foundation Albiz (hereinafter: the Council) is the highest authority of the Foundation Albiz.

Their rights and obligations of the Council on the basis and within the framework of the general acts of the Foundation Albiz

Members of the council

Article 29

The Council consists of the founders of the Foundation Albiz or fifteen (15) members, a member of the Council may be another person.

Election and Council mandate

Article 30

The right to membership in the Council of donors is acquired by the act of foundation and decision of the Council for a new member.

To change the number of members of the Council of donors decides existing (current) Council by a majority of the number of members of the Council who voted, but not less than one third of the total number of members.

For a new member of the Council decides (current) Council by a majority of the number of members of the Council who voted, but not less than one third of the total number of members.

President of the council of the donors.

Article 31

President of the donors is responsible for the operation and the decisions adopted by donors.

President of the donors as well as vice president, elected by the Council of donors, with a majority of the members of the Council of donors, for a term of one year with the right to re-election.

In case of absence and inability of the President of the donors, he is replaced by vice-president.

Scope Council

Article 32

Council of donors:

- Adopts, amends Articles;
- Adopts general policy and strategy;
- Approves the annual report and financial report with a report from the independent auditor;
- Elect members of the Management Board;
- Decides on status changes and termination of Albiz Foundation;
- Performs other duties in accordance with the Statute and general acts of the Foundation Albiz.

Work of the council

Article 33

Council works in sessions.

It meets at least twice a calendar year and if needed.

Council sessions are convened by the President of the Council of donors, on its own initiative or at the request of the Council of donors, or at the request of five members of the Council.

If the President of the Council of donors within fourteen days after the request does not call, the session is convened by the Council of donors or initiators.

Council may sit in session if there are at least five (5) members and decisions are valid if they won unanimously.

Council shall adopt rules of work (rules) by a majority vote of the members.

Keeping sessions

Article 34

The meeting of the Council is chaired by Chairman (President of the Council).

Proceedings of the Council

Article 35

For the Council proceedings are kept data provided by the rules. Proceedings are taken by a clerk.

4. MANAGEMENT BOARD

Definition of a board

Article 36

Management Board is a body of general management (Management Board) Foundation Albiz.

Their rights and responsibilities to the Board on the basis and within the framework of the general acts of the Foundation Albiz.

Members of the management board

Article 37

The Management Board shall consist of at least seven but not more than eleven members. The number of members of the Management Board is adopted by the Council of donors.

Election and mandate of the management board

Article 38

Board members Board of Directors are elected by the Council of donors by a majority of the number of members of the Council who voted, but not less than one third of the total number of members. Board members serve for a term of four years, eligible for re-election an unlimited number of times.

Chairman of the Board

Article 39

Chairman of the board of directors is responsible for the work and decisions of the board of director's. In case of absence and impediment of the Chairman of the Council, it replaces under-chairman.

Chairman of the board and vice president is elected by the Board of Directors, with the majority of members of the Board, upon recommendation from the Council of donors. Chairman and replacement of the management board are appointed for a term of four years, with the opportunity to be appointed to a four-year term, a number of unlimited times, for an unlimited number of times.

Responsibilities of the Board

Article 40

Board of Directors manages the Foundation Albiz within the law and the Statute and general acts of the Foundation Albiz.

Board of Directors:

- Assist the Council to define the general policy and strategy of the Foundation Albiz.
- Adopts the perspective and annual programs and work plans and financial plans proposed by the

Director;

- Adopt general acts of the Foundation Albiz other than acts adopted by the Council and monitor the implementation of the Statute;
- Adopts the quarterly and half-yearly reports and monitor the implementation of programs;
- Better manage and take care of the property and assets of the Foundation Albiz;
- Offers independent auditor (auditing company);
- Adopt the annual accounts;
- Prepare, establish and implement decisions of the Council;
- Decide on the membership of the Foundation in domestic and international alliances and organizations, with a recommendation from the Council President
- The Council shall submit proposals for the appointment or dismissal of members of the Board.
- Supervises, monitors and controls the operation and activities of the Foundation, especially its use of

Means for the purposes specified in this Statute.

- Decide to allocate the funds to the Foundation within the financial plan.
- Request and inspect documents and explanations required by the Director or any employee of the Foundation are in connection with any aspect of the activities of the foundation.
- Within its powers Chairman of the Board represents the Foundation and established contacts with third parties and the public to promote the goals attitudes and activities of the Foundation.

- Gives proposals to the Council concerning the amendments to the Statute
- To adopt other decisions relating to the activity of the Foundation, except those that are the exclusive competence of the Council.
- Approve the proposals of the Director for the establishment of subsidiaries (branches) in the country within the Foundation.
- Adopt an internal act on the organization and systematization of the working places of the Foundation.
- Performs other duties in accordance with this Statute and general acts of the Foundation Albiz.

Modus operandi of the Board

Article 41

The Managing Board makes decisions at meetings.

The Managing Board holds at least seven sessions per calendar year.

The meetings of the Board shall be convened by Chairman of the Board, on its own initiative or at the request of two members of the Board or at the request of five members of the Council or at the request of the Executive Director. Chairman of the Board must convene a meeting within four days of the request.

Convocation is performed by invitation in time, place and proposed agenda.

For working sessions take minutes (written and audio), which endorsed President and CEO.

Management Board shall adopt rules of procedure by a majority vote of the members.

5. MANAGEMENT

Executive director

Article 42

Executive Director's executive body is an organ of the daily management of the Foundation Albiz. Executive Director shall be elected as a Board of Directors by a majority of the number of members

who voted, but not less than one third of the total number of members, in compliance with a decision of the Council of donors.

The Executive Director must be a person of integrity and competence.

The Executive Director is elected by public announcement, which is published in at least two daily newspapers.

The method and procedure shall be regulated by general act adopted by the Management Board.

Executive Director of the Foundation Albiz cannot be a person who performs the functions of chief executive officer or agent of another entity.

The Executive Director is responsible to the Council of donors and the Board.

The mandate of the Executive Director is four years, eligible for re-election an unlimited number of times.

Scope of Executive Director

Article 43

The Executive Director manages the business process of Foundation Albiz. Their rights and obligations are performed on the basis and in the framework of the general acts of the Foundation Albiz.

Executive Director:

- Represents the Foundation Albiz in legal relations with third parties responsible for the lawful work of the Foundation Albiz and the proper implementation of the Statute and general acts of the Foundation Albiz;
- Executive Director is the chief administrative officer. He is also secretary of the general management bodies (Board of Directors) and surveillance (Council of donors). Executive Director participates in the work of the Council and the Management Board without right out loud;
- Lead workflow Foundation Albiz and manages it;
- Monitor and analyze the situation and problems in the activity of the Foundation Albiz provides forecasts and predictions of future conditions, problems and opportunities, communicate and collaborate with other organizations;
- Takes care of strategic planning and prepare promising annual and periodic programs and work plans and financial plans. Is responsible for the execution of the program and the work plan and financial plan and periodically brings the annual performance reports and financial reports to the Board and Council of Donors.

- Manage ongoing organizational costs which arise from the implementation of activities, programs and projects, which were adopted in the Board of Directors;
- Manages the organizational running costs arising from the implementation of activities, programs and projects, which are approved by the board of directors
- Establish appropriate procedures for the work of the Foundation Albiz, census forms and other committees;
- Ensures the proper and economical operation of the assets of the Foundation Albiz and manage cash flow;
- Decide on the managers of the Albiz Foundation in compliance with a decision of the Board.
- Decide on employment, lead and motivate associates, establishes indicators and assesses operating achievements.

Executive director performs other issues within its competence in accordance with the laws, statutes and general acts of the Albiz Foundation

Responsibilities of the Executive Director

Article 44

The Executive Director is responsible for:

- Legality, regularity and timeliness of the work of the Foundation Albiz and for providing working conditions in accordance with the law, the Statute and general acts of the Foundation Albiz;
- Preparing timely, objective and accurate presentation of the financial report
- Continuous monitoring and management (Management Board) with the risks it is exposed Foundation Albiz, including analysis and assessment of the reports submitted by financial institutions.

Continuous monitoring and management (Management Board) of the risks to which it is exposed Foundation Albiz, including analysis and assessment of the reports submitted by financial institutions.

Managers

Article 45

In Albiz Foundation, in addition to the Executive Director, there are other persons with special rights and responsibilities.

For the Election of the Executive Director decides, in accordance with a decision of the Board.

The transfer of powers

Article 46

Executive Director may transfer certain powers stemming from rights representing Albizia Foundation.

Powers can be transferred to managers or other employees of the Foundation Albizia.

The transfer of powers can apply for concluding and signing of individual acts of Albizia Foundation.

In all cases referred to in the preceding paragraphs of this article, persons who are transferred powers report to the Executive Director.

The powers can no longer be transferred, without a decision by the Executive Director.

Executive office

Article 47

Albiz Foundation is organized in an executive office, which is responsible for management, as well as for professional and administrative issues he addresses the daily issues, the support of the authorities of foundation Albiz and implementation of policies and programs approved by the authorities of the Foundation Albiz.

Composition of the executive office

Article 48

Executive Office consists of the CEO, senior executives and the required number of associates employed by the Foundation Albiz.

Executive Directr chooses collaborators governed by the principles of integrity, competence, efficiency and affirmation.

The organization and work of the executive office are governed by regulations adopted by the Board.

Scope of executive office

Article 49

Executive Office:

- Monitor and analyze educational, cultural, economic and socio-humanitarian social trends and problems;

- Prepare meetings of the general management (Board of Directors) and surveillance (Council of donors) and related materials;
- To implement all the planned activities of the Foundation Albiz, within legal limits annual work plan and financial plan;
- Prepare medium and annual work plans and financial plans;
- Works with financial resources to ensure maximum vicissitudes, mobilize new funds;
- Perform office work and archive and accountancy;
- Submit reports and financial statements;
- Identify and formulate programs, prepares documentation and care the implementation of program activities, their monitoring and evaluation;
- Maintain relations with the public.

V. FINANCING OF THE FOUNDATION ALBIZ

Sources of funding

Article 50

Foundation Albiz acquire property, collects funds from: founding deposit; Donations from founders and other donors; contributions, gifts and bequests; performing its own activities; loans; borrowed funds purchased wills, donations, charity campaigns, auctions, sale of property; profits of companies that foundation established by assets, to achieve the goals and tasks defined by the Statute; government funds from the budget of the Republic of Macedonia; and other sources of funding that are in accordance with the laws of the Republic of Macedonia.

Assets acquired in accordance with paragraph 1 of this Article shall be owned by the Foundation.

Intended use of funds

Article 51

The resources of the Foundation Albiz are used for specific goals, objectives and activities, in accordance with this Statute and general acts of the Foundation Albiz and in accordance with the regulations and restrictions on the sources of funding.

Intended use exceeded revenues over expenses

Article 52

Excess of revenues over expenses (profit) generated by Albizia Foundation cannot be distributed as such by any individual, but should be used exclusively to achieve the goals, objectives and activities of the Foundation Albiz

Annual plan

Article 53

The financial year coincides with the calendar year.

Amount and method of allocation of funds to the Foundation Albiz are determined each year by the financial plan, based on the annual work plan.

Annual plan, including the financial plan is adopted by the Management Board.

The annual plan is approved each year at the end of the current calendar year, for next year.

If the annual plan is not adopted within the period specified in paragraph 4 of this Article, the funding of the Foundation Albiz will be made in the amount of funds from the previous year, increased with the growth of retail prices in the current year.

In case of the condition of paragraph 5 of this Article, the financial plan will be adopted no later than March 31 of the current year.

Accounting books

Article 54

Foundation Albiz accountancy, maintains the books submitted annual accounts and an inventory list as provided by law.

Board of Directors an act to regulate financial operations.

Board of Directors approves the census reports.

Annual accounts and annual report

Article 55

Albiz Foundation has an annual work report, annual accounts and financial report in accordance with the Statute and general acts of the Foundation Albiz.

Executive director of Albiz Foundation is responsible for the damage of the Foundation Albiz caused by his work, if it is caused by negligence or conscious in order to cause damage.

Article 59

Foundation Albiz protect its interests with measures that include (but are not limited to) business secret, prohibition of competition and conflicts of interest. Foundation Albiz has the right certain data and information essential for its business interests to establish a business secret.

Conflict of interest

Article 60

Conflict of interest means a conflict of powers and duties related with the working of the Foundation Albiz by existing a personal interest of the person, who has powers and duties (as the member of the general management (Board of Directors) and surveillance (Council of donors) and executive director and persons with special rights and responsibilities), in which personal interest affects or may affect the performing of the authorizing and duties related in working of the Foundation Albiz.

VII. PUBLIC WORK AND INFORMATION

Keeping acts

Article 61

Foundation Albiz at its head office in the archive keeps acts in accordance with the law. Board of directors regulates the way of archive office working.

Publicity in the work

Article 62

The work of the Foundation Albiz is public. Board of Directors is obliged to provide a system of informing the public.

Publications

Article 63

Foundation Albiz may establish periodical publications in order to realize the goals and objectives, and also the annual financial statements and lyrical activities of the working will be annuanced on the official website.

VIII.STATUTES AND AKTS OF THE FOUNDATION ALBIZ

Arrangement of Foundation Albiz

Article 64

Foundation Albiz be regulated in accordance with the Law, with this Statute and general acts of the Foundation Albiz. Foundation Albiz brings Statute, rules of procedure, decisions, resolutions and other acts. With the rules and decisions are regulated the issues by the Law or by this Statute is intended to be regulated by general legislation.

Priority application

Article 65

Statute is the highest act of Foundation Albiz. General acts of the Foundation Albiz must be in accordance with this Statute. If a provision of general act is not in accordance with this Statute, it is invalid from the provisions of this Statute.

Amendments to the Statutes

Article 66

Council brings, modifies and completes the Statute.

Proposal for amendments to the Statute may be submitted at least three Council members or five members of the Board or executive director.

The proposal decision on amending the Statute which listed the proposed changes, with their explanation, no matter who gave the initiative, it considers and approves the Board of Directors and, together with own opinion and a revised text of the Statute is submitted to all Council members, fifteen days before the session of the Council. The Council adopted amendments to the revised text of the Statute, a two-thirds majority of the members.

Signing general acts

Article 67

General acts of the Foundation Albiz are signed by the President of the Management Board and Executive Director of the Foundation Albiz.

IX. TERMINATION OF THE FOUNDATION ALBIZ

Termination of the work

Article 68

Foundation Albiz terminates its work if it decided by the Council by a two-third majority of the members.

Foundation Albiz terminates:

- If it is determined that the funds are not sufficient for achieving its goals and objectives;
- If it loses its property;
- -If the purpose for which it is formed cannot be accomplished
- -in case of bankrupt
- If it works against the Law on Associations and Foundations
- -Fondacion Albiz stops working and in accordance with legal regulations.

X. TRANSITIONAL FINAL PROVISIONS

Article 69
